Schwartz Center Historic Milestone Markers

Below is a listing of key historic milestones and how they helped to shape the Center over the last six decades of service:

October 28, 1941	A son with cerebral palsy is born to Agnes (Posa) and George Raposa.
1947	Cerebral Palsy Council of Bristol County organized by Posa.
May 9, 1949	Agnes "Posa" Raposa elected President of the Cerebral Palsy Council of Bristol County.
1951	Dr. Isaac H. Schwartz named Medical Director at Sol-e-Mar Hospital for Children (later to be named Schwartz Center).
January 19, 1964	Center opened at 374 Rockdale Avenue and named Cerebral Palsy Clinic.
March 20, 1970	Isaac H. Schwartz, M.D., passed away. A few months later the Center was subsequently named in his memory.
June 16, 1974	The north wing was dedicated as the Samuel Kaplan Wing.
September 20, 1981	The south wing was dedicated as the Eva Kaplan Wing.
September 1987	Chapter 766 Day School Program begins.
December 5, 1989	Sun room completed and named in memory of Medical Director, Peter W. Sweester, M.D.
December 1991	Posa retired as Executive Director. Barry De St. Croix named Executive Director and Carol Almeida named Director of Operations.
October 1993	Schwartz Center Early Intervention Program began.
1994	Leonard and Hilda Kaplan establish a fund for the Center.
1997	Schwartz Center celebrates 50 years of service to children.
2003	"Achieving Our Potential" Capital Campaign begins.
2004	Center receives donation of land in Dartmouth from Mr. Stanley Goldstein.
September 2006	Schwartz Center opens in Dartmouth off of Old Westport Road.
September 2008	Barry De St. Croix retires as Executive Director, Mary Hodgson named Executive Director.
2009	Dr. Lund retires, Dr. Harry Webster is named Medical Director. Family University and Lectures Series launched. Developmental Evaluation Clinic in affiliation with Children's Hospital Boston is launched.
